Tournament Rules

1. The Star City High School Open is sponsored by the Lincoln Bowling Association and is open to bowling teams of high school students (grades 9-12) in good academic standing and attending a high school (public or private) in the United States of America, that meet the following conditions;
 - a. Nebraska teams must be composed of students in accordance with the Nebraska High School Bowling Federation By-Laws (www.nshbf.com).
 - b. Non-Nebraska entries will be allowed in accordance with their respective states athletic association guidelines and regulations (HSBUSA recognized).
 - c. If no state guidelines, teams must be comprised of students attending one school, if the student enrollment of that school is 900 students or more. A team may combine students from two high schools if the enrollment of both school is less than 900 students.
 - d. Any team that did compete in their USBC recognized state high school bowling program the immediate season prior to the SCHSO, may only participate with a team of student-athletes comprised of one single school (no new "co-ops").
 - e. All state-approved combined (co-ops) school teams must request permission, in writing, from the tournament director prior to competition, or will be disqualified.
2. The Star City High School Open is certified by the United States Bowling Congress. This event is governed by the USBC Youth Division. Students must present their USBC certification card AND acceptable form of student ID at the time of check-in or they will be required to pay a \$5 participation fee. Incomplete team/singles entry information will be rejected and returned. Only completed entry forms will be accepted. Teams withdrawing from the event within five days of the event start date will not receive a refund. Only paid entries reserves a spot.
3. Scholarships are underwritten by the Lincoln Bowling Association. Team entry fee of \$150 is due 10/29/18. MC/VISA/AmEx/Discover accepted with a \$5 processing fee.
4. Team Event - there will be separate boys and girls squads, each limited to 32 teams. All competition will be scratch. Schools may enter multiple teams, in accordance with the eligibility rules. The top 8 teams will advance in the division if less than 17 entries. The top 12 will advance if less than 28 entries. The top 16 will advance if 28 or more entries. The finals will be on Sunday.
5. Playing strength of teams shall be five bowlers, although a team's roster may carry up to seven players. No straw scores will be allowed. Each participant may enter only once.
6. Two player substitutions are allowed at any time during a regular qualifying game or Baker game. Baker lineup and/or substitutions may be made prior to the start of any Baker game. Additional substitutions will only be allowed in the event of an injury and the permission of the tournament director.
7. Players should be dressed with like shirts printed with the school/team name. Sweatpants, denim jeans, shorts, hats, and T-shirts with obscene or offensive material will not be allowed. Teams are encouraged to wear like slacks or skirts. DENIM IS NOT ALLOWED!!!
8. Tournament Agenda:
 - Saturday- 8:00am Team Registration (Girls squad), 8:30am Coaches Meeting, 8:50am practice, 9:00am Girls A squad begins qualifying, all girls teams bowl 4 regular games.
 - Saturday - 12:30pm Team Registration (Boys Squad), 1:30pm Coaches Meeting, 1:45pm Squad Announcements. 1:50pm squads practice, 2pm squads begins qualifying, all teams bowl 4 regular games.
 - Sunday*- 8am double-elimination rounds begin (*best 3 of 5 Baker Matches)*
9. All players, coaches, and spectators are expected to behave in accordance with the NSAA Code of Ethics. Abusive behavior and/or gestures will not be tolerated and may result in a player or team removed from the tournament. Only players, coaches and tournament officials will be allowed in the bowler's areas. No outside food or beverages allowed. No outside step stools, ladders or furniture will be allowed into the center. Any rule not covered herein will be decided by the tournament director, whose decision will be final and binding. Any protests must be in accordance with Rule 329.
10. A minimum of \$6,000 in college scholarships will be awarded between both events. Team scholarships awarded as follows;
 - Boys 1st - \$1500, 2nd - \$750, 3rd - \$500.
 - Girls 1st - \$1500, 2nd - \$750, 3rd - \$500.The high boys and girls individual series (during team qualifying) on each qualifying squad will receive a \$125 scholarship.
11. Any rules not covered here will be settled in accordance with USBC rules. The decision of the Tournament Director shall be final unless an appeal is made in accordance with Rule 329. If during this event an act of God prevents its conclusion, the standings will be final as of the last completed round.
