Official Rules

1. Any combination of 5 USBC members may bowl. All teams will bowl 3 regular games.
2. Handicap will be 80% of 1100. Teams will receive no handicap below a minimum team average of 750.
3. **Average to use in this tournament will be the highest final association book average of at least 21 games from 2010 – 2011, or your current average of at least 12 games, whichever is higher. All others must bowl scratch. Sport league averages must be reported. The sport conversion chart will be used. Any bowler who has been rerated or adjusted for any bowling competition must report that average. The tournament director may adjust any bowler's average prior to bowling.**
4. Entry fee is \$110.00, broken down as follows: Lineage = \$45.00, Prize Fund = \$48.00, Expense Fee = \$7.00, State Prize Fund = \$10.00.
5. There is no straw or absentee score. A tardy bowler will receive 0 pins for frames missed.
6. In District qualifying, cash payback is on a ration of 1/5. Teams with the same 5 bowlers may bowl more than once, but may cash only once in each tournament with the same 5 bowlers. Teams must switch at least 2 bowlers in order to cash more than once.
7. Any team that cashes in a District tournament is eligible to bowl in the State Finals.
8. These tournaments are sanctioned by the USBC and all other rules not covered here are applied.
9. The on-site Tournament Director appointed by the NSBPA will decide any rules dispute not covered herein.
10. The team captain will designate which center is to be represented by his/her team.
